Sigma Pi Brotherhood Confronts Hate

Since the horrifying Hamas attacks of terrorism on October 7, tensions have been high globally and on the Cornell campus. Despite all the chaos on social media, one thing remains clear: it is our duty both as humans and as brothers of a fraternity to support each other now, more than ever. Here on campus, humanity's strengths and weaknesses have both been poignantly evident. On October 11, the Cornell Jewish community came together to hold a vigil on Ho Plaza for student solidarity and to honor those whose lives have been lost in this crisis. The Jewish brothers of Sigma Pi were all in attendance along with supporting brothers. It was a powerful night that reminded us all that the best way to get through such a terrible time is to come together.

Other members of the Jewish community here at Cornell have been putting up posters and using their voices to make sure that the pertinent issues are not getting swept under the rug and that the community is being held accountable for any hate or avoidable ignorance. Even still, these posters are getting torn down as there are students and community members with differing opinions. The alarming language used, even by our own

faculty members, has added to the tension, stirring further division and leaving some of our brothers questioning their safety on campus. A vigil for Palestinian lives lost took place on Ho Plaza on October 18. From what I have seen Cornellians generally and certainly the brothers of Sigma Pi have remained grounded through their efforts to be as educated as possible, be as empathetic as possible, and form their own well-informed opinions. Terrorism should always be vehemently condemned, and, while it took two emails, President Martha Pollack and the Cornell administration have done so.

Sigma Pi and our fellow Cornellians have thus been in the process of digesting the situation as it unfolds and will continue to do so. As a brotherhood, we have joined other fraternities and sororities in a fundraising initiative for Israel's National Emergency Medical Service, Magen David Adom, and there has been a continued dialogue amongst our leadership on what the best next steps are to show solidarity within our local community. Mu Chapter of Sigma Pi has always been strong in the face of adversity and I am confident that, during this difficult time, our alumni and current students alike will uphold that strength and continue to educate ourselves, support each other, and lead our various broader communities.

Re-imagine Sigma Pi

We are at a crossroads.

If you paid attention to the annual report and the last Muse, you are aware that Facilities Co-chairman **Liviu Rusu '98** has spent a significant amount of his personal time, not only actually doing much of the work, but also supervising/coordinating the rest. The house appears better than it has in many years.

While the superficial appearance is quite good, much of the underlying infrastructure is old and in need of significant attention. Our first road in this "highway repair" is riddled with:

- **Old Bathrooms:** Other than the rework of the second-floor shower area in 2017, the rest of the bathrooms have been essentially untouched (other than minor repairs) for about 30 years. There are frequent leaks to lower levels. Poor ventilation causes mold problems. And the old design is simply not appealing. A significant amount of work is required to repair this pothole.
- **Heating Ventilation and Air Conditioning (HVAC):** In reality, we only have the "H." Our antiquated, gas-fired boilers with hot water radiators are 40 years old. Two of the boilers are past their expected lifetime and will have to be replaced soon. Multiple leaks over the years have caused water damage. There is no "V," ventilation: no forced air flow, filtration, or fresh air replenishment (other than windows which aren't very effective with the long Ithaca winters). And, the "AC," air conditioning, is limited to window-installed units. They are a fall hazard when installed by undergrads, inefficient, and an eyesore. Replacing the boilers and doing a better job of installing the window units could patch this pothole.
- **Doors:** There is a mismatch of wooden and metal doors. Most have some damage. Door hardware is not standard dimensions and there are limited spare parts. One vendor recommended replacing doors and doorframes instead of getting new doors. With 25 bedrooms and a dozen common rooms, replacing all of these fire doors is not an insignificant pothole to patch.
- **Front Porch:** After heavy rains, there is intermittent leakage from the porch into the dining room below. Attempts to locate and repair the leak have been unsuccessful. The supporting structure is partially degraded, a likely contributing cause of leaks. We need to rework the entire front porch: support structure, waterproof membrane, and deck material.

As I'm sure you all are aware, fraternity life is challenged on many fronts. While the reports to our members documented a few not-so-good years, our feeling is that we are currently on an upswing. However, we are still operating on a cash-in and cash-out basis. A little cushion after the good years; not so much after the not-so-good ones.

Our second road? Brother Liviu once again lit a bright light for us last summer by spiffing up many of the rooms and renting them out via Airbnb. We had multiple individual renters and rented the second floor to a youth group for a week (with the organizers indicating their interest in making this a recurring rental). Our house sits empty for a third of the year generating only utility, tax, and insurance bills. We are excited about the possibility of further developing this significant source of rental income.

However, communal bathrooms, little ventilation, and window air conditioners severely limit our rental opportunities. With improvements, we could be generating a significant income instead of the house sitting vacant, and at the same time making the rooms and house much more appealing to undergrads (i.e., providing significant help with rush).

And so to our crossroads: do we simply fix the potholes, or repave both roads with a good path into the future so we create a re-imagined Sigma Pi? We suggest the latter. With severely degraded boilers and bathrooms, it simply does not make sense to address them individually while we are considering significant improvements in the future.

Our plan:

- Replace the existing heating system with electric heat pump heating and air conditioning, and forced air flow and filtering. Financial incentives are currently available to convert to an electrical system. And Ithaca, which has already banned new gas installations for heating, is considering placing limits on future gas heating replacements.
- Redesign the bathrooms to provide private baths for the adjacent eight bedrooms.
- Remove the unused chimney for the east lounge fireplace, opening space to add private baths to six more bedrooms.
- With these changes, the boiler rooms on the second and third floors will become empty. By taking space from walk-in closets in adjacent rooms, the boiler rooms could be converted to singles, or simply kept for much-needed storage. This is a decision to make later.
- And we will still need to address the doors and front porch.

This is not a small undertaking and we are still in the planning stage. We're putting together a committee to manage this project because it is simply too much for Liviu and me to handle along with ongoing routine maintenance. We'd really like someone to step up to be our foreman on this one, along with "skill workers" who have experience in specific areas we are addressing. We are also looking for some utility players to simply help carry the load.

And of course, we will need to fund these improvements. All can help in that area.

Facilities Report

I'm thrilled to report that the house as a whole is in good shape. The culture of the brotherhood has shifted from prior years, led by Nevin, our current house manager.

The common areas have been kept in exemplary shape this semester, to the extent that Pristine Cleaning has had time to clean the grab-and-go area regularly, a welcome new development.

Overall, I'd give the house an eight out of 10. But that average is just that.

If we think of the house in layers, like an onion, the outer parts, the exterior and common areas, get a 10. The inner layers, like the mechanical systems and bedrooms, don't fare as well.

Despite our summer focus on individual rooms, we only addressed 10 of the 25 bedrooms, and the attention was strictly on the walls and ceilings. Those addressed were the ones that required the least input to bring to a rentable condition for Airbnb. The remaining rooms have extensive drywall damage. All the rooms have hardwood floors and doors that have been deteriorating since 1995. The same is true for our mechanical systems. Three of our four boilers have exceeded their service life and require replacement. Replacing the boilers is an option, but it still leaves us with radiators that freeze during winter break, creating floods and disproportionate building damage. On the flip side, window AC units that are used extensively in warmer months, are rarely installed properly and occasionally fall out.

There is an elegant and long-term solution to both of these problems: central HVAC powered by heat pumps. Currently the second and third floor boilers are housed in mechanical rooms near the bathrooms.

A new HVAC system would be housed in the attic, freeing up the mechanical rooms and allowing the space to be re-configured, creating an additional bedroom on each floor, as depicted here.

Although the theoretical occupancy is the same, we've rarely had most doubles used as doubles, with brothers overwhelmingly preferring private single rooms.

In a recent survey, we asked brothers to rate what factors they desire most. They answered: singles, soundproof doors, and air conditioning were highest universally, with older brothers also valuing more privacy in the bathrooms. These facts must be seen in the greater context of changes in the campus, Collegetown, and Ithaca.

Cornell has shifted from the fertile ground for fraternities, with no resident halls, to the completion of the North Campus renovation intended to provide a "unified experience" for freshmen and sophomores with the addition of 2,000 bedrooms and 1,000 dining seats of unparalleled student luxury. On the Collegetown side of the gorge, developments like "The Lux" lure students with amenities like saunas and high-end gyms. And the city of Ithaca has thrown us a curveball, legislating no new gas connections and no replacement of existing gas boilers or appliances in five years.

I don't think it's a matter of if but when we implement these changes and waiting only increases the construction costs and potential liabilities from radiator floods, falling air conditioners injuring someone and us struggling to keep the house full and the operational expenses covered.

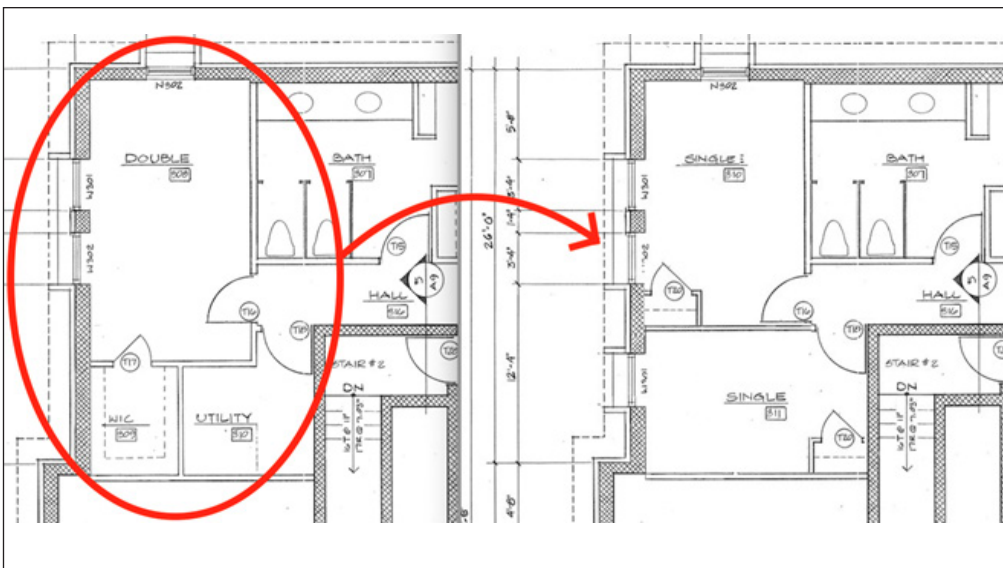
The Facilities Committee, headed by John Morrison and me, continually tracks the state of the house and we always have a list of projects to execute pending financial resources. Those resources have been slim in recent years with smaller pledge classes and many juniors studying abroad. That leaves us stuck between the proverbial rock and hard place.

Ultimately, we need to increase rent revenue, but there's a limit to school-year revenue, and until now, we've paid for summer expenses without the benefit of rent. I believe we must change that and make revenue year-round by doing what we did this summer with Airbnb, children's camps, and graduate students. We generated \$21K and we can do much better. We estimate between \$60K and \$160K in future

summers depending on the level of improvements we make. But we must "build it before they come" and the cost required to completely optimize rent revenue approaches one million dollars.

To that end, we're reaching out to all our alumni for help, be it with subject matter expertise, organizational skills, or financial contributions.

Sigma Pi has thrived on the hill for 110 years because of the love, support, and involvement of our alumni and that's the only way we'll make it through the next 110.

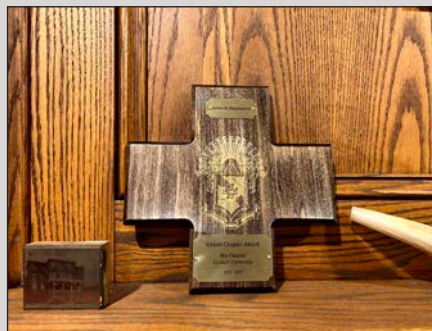
Mu Chapter Wins Grand Chapter Award

The alumni board has a committee structure to provide for more active directors and interested alumni serving on committees to oversee the operation of the house. The committees will do the work that several individuals have done heretofore. Committee assignments are made based on the following criteria:

- Preference of the board member or alumni as to the committee he preferred.
- Consideration of required professional knowledge or equivalent experience.
- Desire to have a larger participation on committees of a general but important nature (Brotherhood, History, and Alumni Relations).
- Membership determined by the by-laws of the fraternity (Executive).

Executive Committee

The Executive Committee consists of the officers of the corporation and the chair of the Legal Committee. The Executive Committee serves as an advisory group to the president. When necessary, the Executive Committee may act on behalf of the board.

Facilities

This committee is responsible for the state of the fraternity house. They will be expected to visit the facility often enough to be aware of physical problems and see that remedial action is taken. The members should be capable of recognizing problems. The chairman is responsible to monitor and supervise the activities of the hired services performing maintenance. The committee will be responsible for identifying future expenditures to maintain the building and furnishings and advise the board of such needs. Membership on this committee will require visits to Ithaca.

Insurance

This committee is responsible for monitoring the insurance coverage of the corporation. The members must be able to certify that systems are in place to ensure insurance is adequate, premium payments are made on time, and to advise the board of any special conditions that could compromise coverage. The corporation currently pays a retainer to an Ithaca insurance agency senior agent to assist in this work.

This committee advises the board as to legal concerns that may arise. This committee also ensures that all notices, filings, fee payments, etc. necessary to maintain the active status of the corporation with the State of New York.

Alumni Relations

This committee will be responsible for monitoring the overt actions of the fraternity to connect with its alumni including the Muse, the Mu Chapter website, and use of The Emerald. The committee will work to see that certain actions are traditional and predictable, including traditional practices such as Homecoming and Reunion. The committee will also oversee and assist the undergraduate philanthropic activities and coordinate with the Mu Chapter of Sigma Pi Educational Foundation as appropriate. Significant interaction with the undergraduate chapter members will be necessary to carry out the mission of this committee.

Brotherhood

This committee will assist the president in ensuring that undergraduates take responsibly for the fraternity's actions, particularly regarding rushing, pledging, and initiation. Currently, there is a committee of board members and undergraduates called the Committee of Seven that is performing this function.

Greetings on a gloriously sunny fall afternoon in Aurora, New York, home of Wells College and its men's football team, undefeated since 1868. It must be true; I have the shirt.

The house remains current on all its bills and is debt-free. The small financial cushion we were able to build pre-COVID and before the elimination of our access to the Cornell bursar billing system has

allowed us to withstand two consecutive fiscal years of an operating deficit. The deficits are driven by two realities. First, fewer brothers are living in the house, and second, not every brother with a bill has paid or paid in full. We continue to work hard at the beginning of each semester to impress on our undergraduate brothers the need to pay their bills. While the number in arrears is smaller this semester, it is still more than a dozen and as of the halfway point of the semester, more than \$50,000 had yet to be collected.

I am pleased to say, however, that the

current house leadership team has stepped up big time and taken a lead role in the unpleasant "collections" activity. **Sage Rob DeJesus '24** and **Treasurer Benji Michael Sliwka '25** have been on point, and what started as over \$100,000 in arrears has been cut in half through their efforts. We hope the remaining brothers will make good on their debts soon and next semester will be even better.

Speaking of next semester, we anticipate a number of newly-initiated brothers will be moving into 730 University Avenue thanks to a change of policy by Cornell.

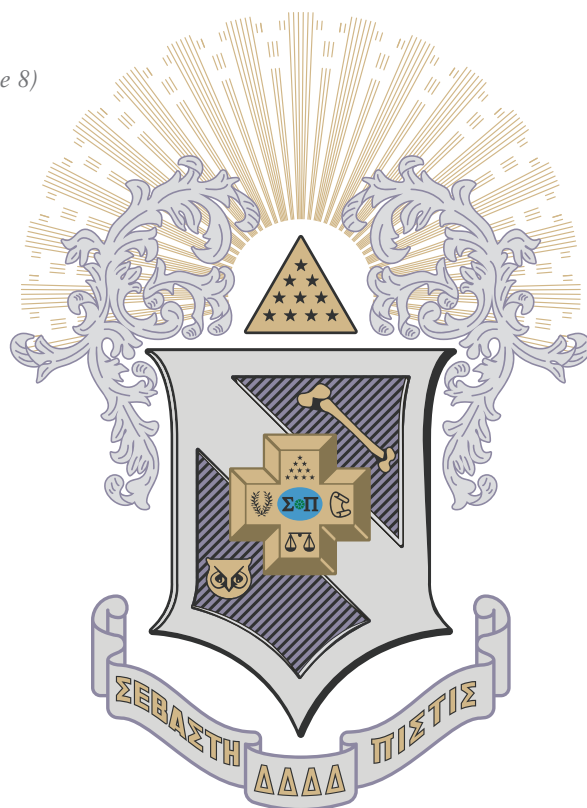

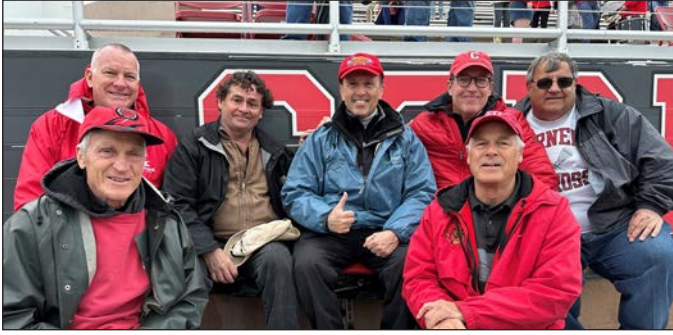
Procrasticup Invitational Goes to the Emerald Isle!
