Sigma Pi Mu Chapter Incident Reporting Procedure

In the event of an "incident" at or relating to the Mu Chapter of Sigma Pi, the Resident Advisor (RA) should be notified immediately along with the Sage and appropriate Undergraduate Officers and continue with the notification process below. In the absence of the RA, the highest-ranking undergradofficer available should proceed with notification of contacts in the order below for each type of incident.

Injury, Violence, or Terrorism

Call 911 immediately in the event any brother, employee, or visitor is hurt, threatened, or in danger.

Then notify: Resident Advisor, Alumni Board President, Alumni Board local Rep, Alumni Board Legal Chair, Alumni Board Insurance Chair,

Property Damage to the Fraternity House or its Contents

Immediately take steps to control and minimize the damage.

If time critical, and extraordinary clean-up or remediation is required, contact ServPro at 1-800-SERVPRO.

Notify: Resident Advisor, Property Manager, Alumni Board President, Alumni Board local Rep, Alumni Board Facilities Chair, Alumni Board Insurance Chair
