Centennial Campaign Update

I have exciting news to share with the brotherhood. I'm delighted to announce that, after completing this year's new-member recruitment drive, we have 18 new brothers, for a total of 70 undergraduate brothers. Next year, 2014–2015, we will have 41 brothers living at 730 University Avenue, with a majority being upperclassmen.

As an expression and statement of their appreciation for the ongoing support of Mu Chapter alumni, the undergraduate brothers have each contributed to the Heritage Centennial Fund campaign. **All 70 brothers (100% participation) have "skin in the game" with respect to this key fundraising initiative to extinguish the mortgage debt and to provide some additional funding for priority infrastructure needs.**

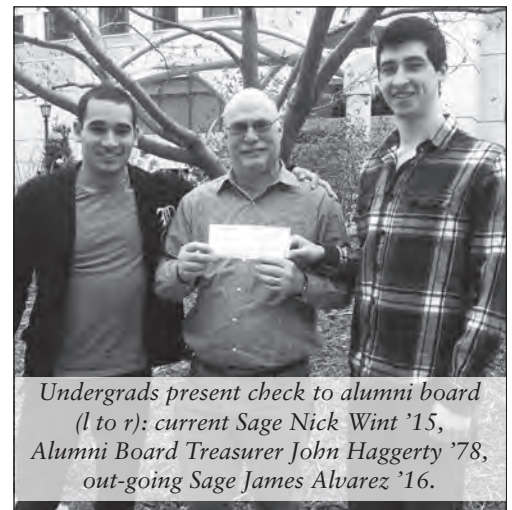

We are currently at the halfway mark of our Centennial Campaign, and we have raised or received pledges/donations in excess of \$136,000 toward our target fundraising goal of \$250,000.

Andrew Walsh is an AEM major from Huntington, New York. He will be working as an Orientation leader next year.

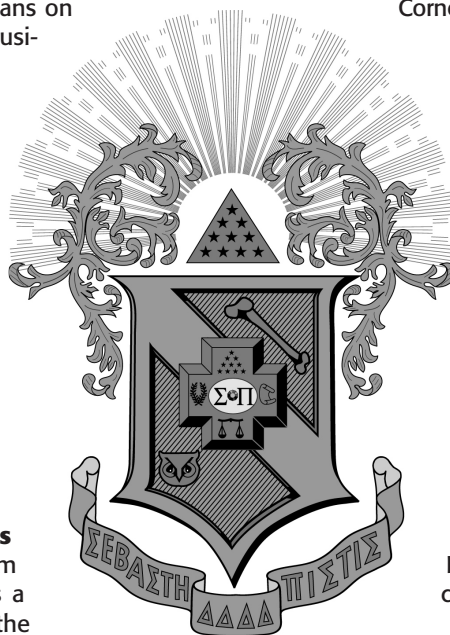
Sam Strang is a hotel management major from Rocky River, Ohio. He is a member of the club hockey team.

Sigma Pi International Dedicates New Headquarters

In late March, **Jim Keene '57**, alumni board member, attended a special weekend celebration to dedicate the new International Headquarters of Sigma Pi International in Lebanon, Tennessee. Lebanon is about 20 miles from downtown Nashville.

The headquarters is a 1906 mansion known as "Mitchell House." It was restored by the Cracker Barrel restaurant chain and served as its corporate headquarters until re-

cently. The first floor, which is a truly impressive space, remains as it was in 1906 and is elegantly decorated and furnished. The second floor of the mansion was remodeled into an imposing modern office suite that handily accommodates the staff of the fraternity.

The first floor is completely equipped with a catering kitchen, a formal dining room and table that will seat 20 persons, foyers, a ladies parlor, porches, and a library that

houses the Sigma Pi Museum's collection of items important to the history of Sigma Pi.

If you find yourself in the Nashville area, it is worth a trip to see the new home of our fraternity!

Mu Unites to Rebuild the Beach

From the countless barbecues under the rare Ithacan sun to the late nights we find ourselves gazing out into Cayuga's waters, the "beach" has always been a place where brothers have been able to form many lasting memories. However, it was recently learned that, in order to maintain the beach's functionality and aesthetic quality, the old deck must be replaced with newly constructed palettes every 20 years. Fortunately for us, Brother **Liviu Rusu '98**, former sage of '97, generously offered to use his expertise and lead the construction project.

To our surprise, the work was a lot more physically taxing than we had initially thought. Moving the lumber onto the beach, removing the old palettes, cleaning the membrane of the roof, and spraying down rubber support pads were all steps completed solely in preparation. The second half of the work consisted of measuring and cutting up the new lumber to construct exact replicas of every old pallet that we were throwing out. Within a couple of hours, the beach had transformed into a construction site, manned by determined brothers.

Despite the expert leadership from Brother Liviu and involvement of over 20 of the brotherhood, only about a quarter of

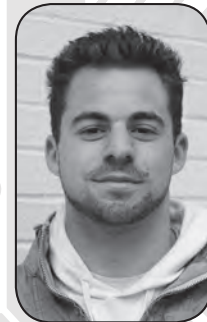
Felix Tabary is graduating from the hotel school and plans on working for Bloomberg in New York City.

The alumni board has created a committee structure to allow more active directors and interested alumni to serve on committees that oversee the operation of the house. The committees will do the work that several individuals have done heretofore. Committee assignments are made based on the following criteria:

- Preference of the board member or alumni as to the committee he would like to serve on.
- Consideration of required professional knowledge or equivalent experience.
- Desire to have a larger participation on committees of a general but important nature (brotherhood, history, and alumni relations).
- Membership determined by the by-laws of the fraternity (executive).

Executive Committee

The executive committee consists of the officers of the corporation and the chair of the legal committee. The executive committee serves as an advisory group to the president. When necessary, the executive committee may act on behalf of the board.

Facilities

This committee is responsible for the state of the fraternity house. Members will be expected to visit the facility often enough to be aware of physical problems and to see that remedial action is taken. They should be capable of recognizing problems. The chairman is responsible for monitoring and supervising the activities of the hired services performing maintenance. The committee will be responsible for identifying future expenditures to maintain the building and furnishings and to advise the board of such needs. Membership on this committee will require visits to Ithaca.

Insurance

This committee is responsible for monitoring the insurance coverage of the corporation. Members must be able to certify that systems are in place to ensure that insurance is adequate and that premium payments are made on time. They will advise the board of any special conditions that could compromise coverage. The corporation currently pays a retainer to an Ithaca insurance agency's senior agent to assist in this work.

Legal

This committee advises the board as to legal concerns that might arise. This committee also ensures that all notices, filings, fee payments, etc. necessary to maintain the active status of the corporation with the State of New York are made.

Development

This committee will work to facilitate adequate fundraising activity to ensure the financial needs of the fraternity. The alumni board as a whole will determine the financial goals of the fraternity. In the past, fundraising has been initiated in response to specific needs, such as the Heritage Foundation to help pay for the building we now occupy, the McGraw Place Project and the Beach Project, the poet laureate appearance, and the Class of 1980 Adolphus C. Hailstork Prize. A new fund, The James H. Keene III, Class of 1957, Sage Endowment Fund, has recently been set up to subsidize the sage to live in the house. The development committee will also now be responsible for increasing alumni support of the Heritage Annual Fund.

Alumni Relations

This committee will be responsible for monitoring the overt actions of the fraternity to connect with its alumni, including *The Muse*, the Mu Chapter website, and use of the Emerald. The committee should work to

Significant interaction with the active chapter's responsible members will be necessary to carry out the mission of this committee.

Mu Chapter Alumni Board Visits Ithaca

In mid March, leaders of the alumni board trekked to Ithaca for several days of important meetings to help ensure the future of our fraternity.

We first met Cornell's associate dean of students, Travis Apgar, and Kara Miller in their Willard Straight Hall offices. The group discussed the current challenging environment for the Greek system and the most recent travails of other chapters, including Chi Psi (hazing) and ATO (loss of charter). Travis was quick to praise Sigma Pi for its leadership role on campus and was impressed that five directors were visiting him to discuss fraternity issues.

Next, we convened with Stewart Howe at their offices on Triphammer Road. Stewart Howe is the organization contracted by Sigma Pi to provide various membership services (e.g., publish *The Muse*, maintain the website and membership database, etc.). In an open and honest discussion, we reviewed the services provided to our fraternity by Stewart Howe. Together, we forged next steps and agreed on a course of action to improve alumni communications.

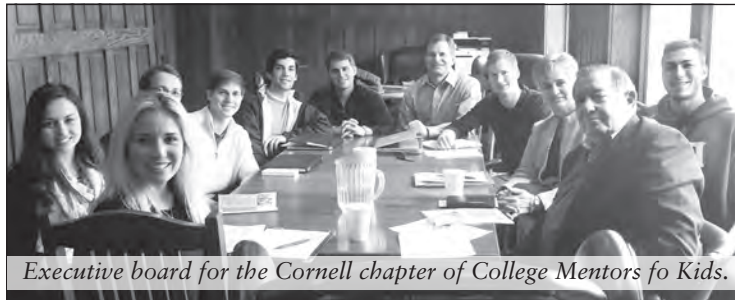
Later that day, we huddled with the house exec-board in the Memorial Library. The e-board members discussed their responsibilities and ongoing activities in the house. Strong positive feelings were expressed about the brotherhood and Sigma Pi's improving reputation on the hill. Specific topics of discussion included the parameters of the new two-year housing lease, the performance and pay of the house cook, the ideal way to conduct meal services at the house, and how to access and redress damage to the house. Actions for each discussion item were assigned. Importantly, it was agreed that all current undergrad brothers would contribute to the Centennial Fund.

Additional key meetings were held with our accountants, Sciarabba-Walker, at their new offices on East Upland Road and with our bankers, Tompkins County Trust Company, over breakfast at the State Diner (yes, *that* State Diner).

Our favorite "meeting" was to break-bread with the undergrads at dinner at the house. Patrick provided an enchanting repast of ham, green beans, and a Dolly-inspired, unidentifiable bread/potato mix-

ture. Interestingly, meals are now generally served buffet-style, without waiters. After the meal, during announcements, each board member shared his personal view on matters important to the house and the brotherhood. On a personal note, I was pleasantly surprised to see that finger-snapping is still the accepted means of expressing approval at a gathering of brothers.

The alumni board devoted a fair amount of time to observe the progress of the new Cornell chapter of College Mentors for Kids. This inspiring, non-profit organization is headquartered in Indiana and provides one-on-one, on-campus mentoring (see collegementors.org). At 25 different college

campuses, mentors help first- through sixth-grade kids understand the importance of education, show them the benefits to cultural understanding, and teach them ways to give back to their community. The Cornell chapter is the first one founded in a state that is not contiguous with Indiana.

The Educational Foundation of Mu Chapter Sigma Pi identified College Mentors for Kids for the philanthropic and leadership opportunities it could provide to the brothers. In addition to directly benefitting the brothers, establishing and leading this new organization could help showcase the true potential of the Greek system to positively influence campus life. The initiation of this effort was proudly announced on Centennial weekend. Bringing this organization to campus has been a genuine team effort. The Mu Chapter Educational Foundation provided the seed-money, **Sandy (Meek) True (House Sweetheart '78)** opened-doors with her extensive network of connections in the Ithaca community and school system, **John Haggerty '78**, in his position on the ILR faculty, helped us navigate the labyrinth that is the Cornell administration, and Sigma Pi current-active brothers stepped up to the plate and provided the undergraduate leadership.

During our visit, the alumni board attended the executive-board meeting for Col-

lege Mentors (which is always held in the Pi house!) to offer its sage advice. Following the meeting, the directors were joined by Ithaca community leaders and members of the Cornell administration at the weekly on-campus "activity." Over 30 second-grade "little buddies" from Caroline Elementary School met their Cornell student "big buddies" at the Robert Purcell Community Center on North Campus. The highlight of the activity was a presentation by Prof. Bruce Monger, Earth and Atmospheric Sciences. Prof. Monger, whose Introduction to Oceanography class has replaced Psych 101 as the most popular course on campus, entertained the gathering with an introduction to the world of oceanography and the path he took to become a scientist.

Later that evening, the alumni board hosted a special dinner at the Statler to honor and thank the invited guests and the undergraduate leaders. I am very proud to say that, thanks to a strong group-effort, Sigma Pi Fraternity is leading the way for the Cornell chapter of College Mentors for Kids. Moving forward, we will be increasing our efforts to promote improved academic achievement in the undergraduate brotherhood. 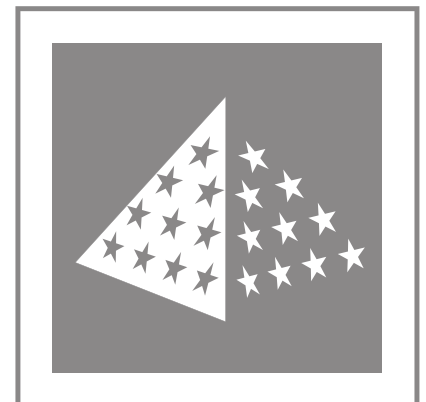

Remembering Ed Finnerty '82

The brothers of Sigma Pi were deeply saddened to hear of the passing of **Ed Finnerty**, class of 1982. Ed passed away in late January due to complications arising from heart failure.

One of seven children raised in Watertown, New York, Ed's life was characterized by his selflessness and willingness to put his own needs behind those of his friends and colleagues. His years at the Pi house will be remembered fondly for their adventurousness and camaraderie. In Memory of Louis J. Conti '41

Lou Conti '41, one of the more well-known brothers of Mu Chapter, passed away on February 14, 2014. Lou was initiated in 1939 and was an active supporter of Mu Chapter for many years. Lou's brother, **Frank Conti '53**, who passed away several years ago, was also a Mu Chapter brother.

Lou was one of the few alumni brothers mentioned by name in the Centennial dinner program in September. Lou played football and was a member of the 1939 undefeated Cornell team, which was voted national champions. Lou was inducted into the Cornell Athletics Hall of Fame in 1981.

Lou served his country during WWII as a Marine lieutenant, flying dive bombers in the Pacific Theater. He flew photo missions over Japan to prepare for a U.S. invasion. Lou and a group of other Mu alumni who had participated in WWII gathered every fall at Howard Hulford's Curtain Bluff Resort in the Caribbean.

In 1949, he joined the Cornell football

coaching staff. He returned to active military service in 1952 and flew 102 combat missions in Korea. Lou returned to Cornell football from the Korean War and served until he began a business career in 1956, first with GATX, and then as chairman and CEO of Marine Transport Lines.

Lou was a director of Emerson Electric Company, whose management was largely made up of Cornell alumni athletes. Lou and four friends at Emerson, along with former Cornell athletes, provided the bulk of the funds to build Friends Hall on campus. The name they chose for the building commemorates the friendship cemented in Cornell athletic participation.

Lou was awarded the Distinguished Public Service Medal, the Legion of Merit, and the Distinguished Flying Cross. The Cornell Football Association named its most prestigious award the "Lou Conti Lifetime Achievement Award." It recognizes individuals who have made extraordinary contributions to the program over many years. Lou will be missed, but never forgotten.

Mu Chapter is proud to have had such men as members. We celebrate that he was a brother.
